Position of postdoc in the EURAMET (EMPIR) Project 18SIB04 "Towards quantum-based realizations of the pascal", financed by the European Union's Horizon 2020 research and innovation program, is open for application.

Project leader: Prof. dr. Bogumił Jeziorski.

Available positions: 1

We are looking for motivated candidates:

- with a PhD degree in Chemistry or Physics (physical chemistry, theoretical physics), gained not later than in the moment of beginning of employment,
- high-level expertise in computer programming for scientific applications, particularly in fortran language,
- excellent knowledge of the nonrelativistic electronic structure theory, in particular single- and multi-reference coupled-cluster theory,
- knowledge of the methods of the relativistic electronic structure theory of molecules,
- experience in developing electronic structure codes in particular based on the multi-reference coupled-cluster theory
- experience in large-scale applications of coupled-cluster theory
- proficiency in scientific English writing.

The candidate must meet the requirements of art. 113 of the Act - Law on Higher Education dated August 28, 2018 (Journal of Laws of 2018, item 1668, as amended).

We offer: a full time position. Contract with the University of Warsaw from 01.01.2020 to 31.12.2020 with a possibility of half of year extension. After the completion of the contract the candidate is entitled to apply in for open positions at the University of Warsaw.

INFORMATION CLAUSE
