The Dean of the Faculty of Chemistry
announce a competition for the position of **Assistant Professor** (Adiunkt) in a group of
research and teaching staff.

The main duties includes securing the continuity of the Faculty's didactic, scientific, technical and organizational tasks, in particular as regards the implementation of research or teaching projects.

The Assistant Proffesor (adiunkt w grupie pracowników badawczo-dydaktycznych) will run a research in exact and natural sciences, in discipline of chemistry. Available positions: 4.

1. Requirements:

- compliance with the requirements specified in art. 113 of the Law on Higher Education and Science from 20.07.2018 r. (Polish Journal of Laws of 2021, no. 478)
- the PhD or equivalent in chemistry or similar sciences,
- documented experience in didactic.

2. Specific Requirements:

The candidate should:

- propose research themes and plans to raise funds for the realization of own research project (an assistant professor will be also participate in projects gained by professors);
- conduct high-level scientific research;
- be active in raising grants,
- actively participate in the didactic process as well as in organization and modernization of the student classes.

3. Work conditions:

- Full time job based on contract of employment
- Work place: Faculty of Chemistry, 1 Pasteur Str., Warsaw

4. Required documents:

- a) CV and copy of PhD degree in chemistry or related sciences,
- b) information on the processing of personal data (*see template at: <http://www.chem.uw.edu.pl/oferty-pracy/>*),
- c) declaration of reading and acceptance of the rules for conducting competitions at the University of Warsaw (a template available at: <http://www.chem.uw.edu.pl/oferty-pracy/>),

- e) description of research project (1 page max.) with candidate's plans for the next 3 years - *10 minutes presentation during the interview, regarding the research plan, the*

candidate's participation in scientific activities, planned research and teaching intentions will be obligatory,

- f) a description of previous, most important scientific achievements (½ page),
- g) references from 2 people with professor or habilitant title [*opinions of people working in an equivalent position abroad are allowed*] sent directly to the Dean's Office,
- h) didactic opinion from the head of the unit,
- i) list of publications (with copies of first pages) with information about Impact Factor of the magazines in which the articles were published as well as information about the number of their citations in the scientific literature) and presentations at conferences (with information about the type of presentation and its authors),
- j) list (title and co-authors) of patents and patents applications
- k) information about fellowships (domestic and abroad) with its duration,
- l) information (confirmed by an additional letter or printout from the database) about gained grants and specification of applied grants. Please give an information about type of the grant and candidate's role (principal investigator, etc.)
- m) list of Master's and Bachelor's theses, in which candidate was a supervisor,
- n) list of classes,
- o) achievements in the dissemination of science or organizational (i.e. promotion, authorship of scripts, working with talented youth, autor/co-autor student's manual/script).

5. Above mentioned documents please deliver

Documents mentioned in point 4 should be send by e-mail to: dziekan@chem.uw.edu.pl before **12 May 2021, 14.00**. In the e-mail's title please put: name_surname_adiunkt. A template from point 4d) please send in .xls.

In the first step the commission of competition will check the application formally. The information about the date of the interview will be given a week before. The commission of competition will show the assessment report to the Dean. Afterwards Dean ask the Council of the Faculty about the positive opinion about the candidates.

The candidates will be informed by phone or e-mail about the result of the competition before 30.06.2021.

6. Other informations:

- University of Warsaw does not provide a business flat.
- The competition is the first step of employment procedure at University of Warsaw. Its positive result is the basis for further procedure. The whole procedure is regulated in Statute of the University of Warsaw.
