Position of a **Structural Biology Specialist** (**adiunkt naukowy**) in the FIRST TEAM 5/2018 proposal #0242 project entitled " Proteolysis-targeting strategies in bacterial systems for functional studies of proteins and improvement of antibiotics " financed by Foundation for Polish Science is open for application.

Tasks:

- Cloning, mutagenesis and expression of protein constructs in bacterial cells
- Purification of proteins and protein complexes, also with small ligands
- Assays of interactions of proteins with protein partners and ligands
- Structural characterization of proteins, protein complexes and complexes with ligands

We are looking for motivated candidates:

- with a PhD degree in biochemistry or a related field (PhD may be pending defense)
- a very good command of English
- Experience in protein expression and multi-step purification procedures using FPLC
- Experience in structural biology methods and working in a structural biology environment
- Experience in quantitative methods of assaying protein-protein and protein-ligand interactions (preferably also in high-throughput approaches)
- Good skills in working as part of a team

The candidate must meet the requirements of art. 113 of the Act - Law on Higher Education and Science dated July 20, 2018 (Journal of Laws of 2018, item 1668).

We offer:

a temporary contract with the University of Warsaw (full time position/employment contract from 01.04.2019 to 31.01.2022). In the first instance, a trial period of 6 months will be used.
