The Rector of the University of Warsaw has opened a call for applicants for the position of Adjunct, as part of the "Excellence Initiative – Research University" programme.

IDUB project description	The "Excellence Initiative – Research University" is a programme of the Ministry of Education and Science, which enables the University of Warsaw to raise the level of quality of scientific activity, quality of education and, consequently, the international recognition of the University.
	The recruited persons will fulfil the job requirements in the Action I.3.3 – "Institute for Advanced Studies". The objective of this activity is to establish a virtual scientific institute. Its main function will be to initiate, coordinate and provide financial and organisational support for research initiatives whose subject matter and time frame exceed those of the activities which are usually coordinated among the existing research groups, who are carrying out projects in the second priority research area

	(POB II¹), and to manage promising innovative activities whose implementation is difficult or at risk.²
	The recruitment process concerns a research position open to outstanding scientists which has characteristics of "Distinguished Postdoctoral Fellowship".
	The candidate is expected to provide an up-to-date topic of research and to present potential for building research group and applying for national and international grants.
Job description and responsibilities	<ol> <li>carrying out research concerning the project;</li> <li>publishing the results of the research in leading international journals in the given field of science.</li> </ol>
Candidate profile, requirements, qualifications	The competition is open to persons meeting the conditions specified in Article 113 of the Act of 20 July 2018 – The law on higher education and science (Dz.U.2021 item 478).
	The competition is open, without defining a specific theme within the listed scientific disciplines.
	Requirements:
	<ul> <li>the presentation of research plans;</li> <li>within the first 18 months of the fellowship the recipient should submit a grant application to an external funding agency unless the recipient was awarded a grant, which will be carried out at the UW, prior to obtaining a position at the UW;</li> <li>availability to begin working no later than 1 October 2021;</li> <li>a very good knowledge of English.</li> </ul>
	It is possible that after successful completion of the fellowship and fulfilling other conditions presented by the dean of appropriate faculty, the recipient can be considered for the employment at the UW as a regular academic teacher.
Required documents	<ul> <li>a signed application for the opened position with a scanned signature;</li> <li>a cover letter;</li> <li>a copy of the candidate's doctoral diploma;</li> </ul>

	<ul> <li>a description of the research project, which should incorporate existing laboratorial infrastructure at UW and its human resources;</li> <li>a CV, including contact information;</li> <li>a list of publications with citations (without self-citations) according to Web of Science (and the Hirsch index), along with the three achievements which the candidate considers the most significant;</li> <li>letters of recommendation concerning the applicant from at least two senior academic employees – these letters are confidential and should be sent directly to the email address isz-rekrutacja@uw.edu.pl;</li> <li>copies of other diplomas certifying the qualifications of the candidate;</li> <li>a signed and scanned statement in which the candidate acknowledges having read and accepted the regulations as set out in Directive 106 of the Rector of the University of Warsaw from 27 September 2019, concerning the organisation and recruitment procedures for positions of academic teachers at the University of Warsaw.<sup>3</sup></li> <li>a signed statement (scan) of consent to the processing of personal data, which comprises the attachment to this call for candidates.</li> </ul>

# Information on personal data processing

#### Controller

## **Data Protection Officer (DPO)**

The DPO, however, does not perform other functions, such as handling recruitment procedures, collecting recruitment documents, or providing current information on the recruitment process.

#### Purpose and legal grounds of data processing

The personal data of candidates for employment shall be processed for recruitment purposes only.

If your documents include data as included in Art. 9 section 1 of the GDPR (special categories of personal data), processing shall be possible upon your consent to processing such data<sup>7</sup>, which may take the following wording:

The University of Warsaw will also process your personal data in future recruitment processes upon your consent<sup>8</sup>, which may take the following wording:

I consent to the processing of my personal data for the purposes of any future recruitment processes at the University of Warsaw, for the period of the next nine months.

You may revoke all such consents at any time, for example by sending an email to <u>isz-rekrutacja@uw.edu.pl</u>

Be advised that the revocation of your consent does not affect the lawfulness of the processing of personal data, which had been completed upon consent and before its revocation.<sup>9</sup>

#### **Data retention period**

The personal data collected in this recruitment process shall be stored for a period of three months from the date the recruitment process is completed.

In the event you agree to process your data in future recruitment activities, your data may be processed during a period of nine months.

#### **Data recipients**

Officers authorized by the Controller shall have access to your personal data, the processing of which is within the scope of their duties.

### Data transfer outside the European Economic Area (EEA)

Your personal data shall be disclosed to subjects authorized by law. Your personal data may be also processed by the provider of the G-Suite services for education by the Google Corporation in their data processing centres.<sup>10</sup>

## Rights of the data subject

Under the GDPR, data subjects have the following rights:

- to access data and to receive copies of the current data:
- to correct (rectify) your personal data;
- to limit processing of personal data;
